

Stella Comprehensive Car Insurance - New Customer Savings Across Australia Promotion Terms & Conditions

1. To qualify for the Promotional Offer applicable to your state or territory as set out in clause 6A below ("PO"), you must: a. obtain a quote for a new Stella Comprehensive Car insurance policy during the Campaign Period and purchase the new STELLA Comprehensive Car insurance policy while the quote remains valid; b. not be an existing STELLA car insurance policyholder; c. have an insured address in the applicable state or territory at the time of purchase; and d. meet all other requirements in these Terms and Conditions during the Campaign Period ("Eligible Customer"). For the purposes of determining eligibility, the state or territory is determined by the policyholder's insured address at the time of policy commencement. If a policyholder changes their insured address to a different state or territory during the term of their new policy, they will be eligible for the discount that is applicable to their new state or territory as set out in Clause 6A below and their discount will be recalculated and applied on a pro rata basis.
